- 6) Vendor is to patch the PA device into the junction box using vendor's own supplied patch cable. However, FI at the time of wiring installation, the sound equipment is yet to be installed, vendor will leave a patch cable with up to 15ft of slack a s defined in #7 below.
- 7) Vendor is to leave at least 15ft of additional cable behind the junction box (in the drop ceiling) to allow for necessary slack for future moves and to connect the applicable audio devices.
- 8) Vendor is to punch down cable on both ends terminating it on the patch panel as well as the junction box d onotterminatethecablewitha nRJ45connector, instead use the junction box as pictured below).
